Summary of Discussion

1. Welcome by the Chair of M-HSCC Executive Working Group

Deputy Director General Dr Soe Lwin Nyein welcomed the participants and introduced the agenda of the meeting. Participants were informed that annual review meetings for 3 disease programmes were held in December 2013.

2. Presentation by PR-Save the Children (see attached)

Mr Ricard Lacort from Save the Children presented the progress of Myanmar GF grants. The grant performance of HIV and TB were A1 rating and Malaria was rated as B1. Procurement is on track. Number of SRs has increased to 19 and all SRs in NFN were signed.

Discussion Points:

- 40K HR & 76K CSS Unallocated but can be absorbed in these areas later
- PWID gap by 2016 will only be approximately 220 under target.
- HCT Training agreed NAP/NHL, 34 trainings 565 staff and \$ 68,000 in savings from SRs/PR will be used.
- HIV Prevention Package for Key Populations. Work in progress with NAP, UNFPA and UNAIDS
- Malaria May need to re-strategize. Border mapping important
- General 1 review panel for review of EoI for different donors, e.g., GF/3MDG should be used
- Field trips PR will invite partners to join

3. Presentation by PR-UNOPS (see attached)

Dr Attila Molnar from UNOPS presented the updated information on Myanmar GF grants and noted the grant performance as HIV and TB grants at A1 rating and Malaria was rated as B1. The presentation also covered the discussion on the implementation arrangement of GF Mekong RAI grant.

Discussion Points:

- Targets/Budget absorption need further review.
- The review by UNOPS of its supply chain and procurement of TB drugs found handling issues to be cause of breakages
- RAI Malaria proposal focuses on resistance/containment and was considered very strong by GFATM

4. Update on the 3MDG Fund (see attached)

Mr Markus Buhler from 3MDG shared the brief update on 3MDG Fund activities such as HIV, TB, Malaria, prison health and MNCH. He also explained their priorities in 2014.

Discussion Points / comments:

- TRP review should use TSGs for consultation and review of awards/grants as does GFATM. Issue is one of donor and system harmonization.
- Prisoner health NAP needs to be more involved in this alongside the NTP
- Who is providing the technical experience for developing the Comprehensive Township Health Plans? Need a consistent approach. Not each NGO doing their own mode.
- In MNCH, there are 42 townships in Phase I.
 - Cash disbursement: what is final process and how does it involve Central and State officials?
 - Midwife may be overloaded unless there is an integrated approach
 - Urban poor? Increasing numbers and need to be included.

5. 5% French Expertise Initiative

Mr Eamonn Murphy, UNAIDS Country Director, provided the updated information on 5% French expertise initiative. TB proposal was reviewed and approved by ExWG meeting and should be submitted to French Government. Union proposal was reviewed by ExWG meeting and TB-TSG. So, HIV-TSG needs to review this proposal.

6. Update on the convening of TSGs

Dr Thaung Hlaing, Programme Manager, presented the update information on TSGs. There are 7 TSGs: HIV/AIDS TSG, TB TSG, Malaria TSG, M&E and Research TSG, Public Health Emergency and Disaster preparedness TSG, Reproductive health, Maternal, Newborn and Child Health TSG, Health System Strengthening TSG. Dr Thaung Hlaing also presented the composition of each TSG.
